



APPLICATION CONDITIONS

Foreign students are admitted to the institutions of higher education in Turkey on condition that applicants fulfill the requirements for student admission determined by the relevant institution of higher education and approved by the Council of Higher Education.

Who Can Apply?

Students who have graduated from an institution equivalent to Turkish high schools or are in senior year of high school may apply to the undergraduate programs, if they fulfill one of the following criteria:

1. is a foreign national
2. holds a foreign nationality, is a Turkish citizen by birth but by courtesy of the Ministry of Interior has ceased to be a Turkish citizen; or was registered as a minor on the document indicating that the parent has relinquished Turkish citizenship and who can certify that he/she holds an official document regarding the use of rights granted by Turkish Citizenship Law (According to Article 7 of the 5901 Turkish Citizenship Law, (1) “Children born to married Turkish parents, in Turkey or abroad, are considered as Turkish Citizens.” Applicants who apply from abroad should refer to the Turkish Citizenship Law)
3. is a foreign national who has taken Turkish /dual citizenship within this context
4. **a)** is a Turkish citizen who started high school before 01/02/2013, completing the last three years of his/her high school education in a foreign country other than the Turkish Republic of Northern Cyprus (TRNC) including those who have completed their high school education in a Turkish high school in a foreign country other than TRNC)
b) the candidate who started high school after 01/02/2013 completing his/her entire high school education in a foreign country other than the Turkish Republic of Northern Cyprus (TRNC), (including those who have completed their high school education in a Turkish high school in a foreign country other than TRNC) may apply to foreign countries’ admission quotas
5. is a TRNC citizen residing in TRNC, with a high school diploma from TRNC and has taken the GCE AL exam, or a TRNC citizen with a high school diploma from a country other than TRNC between 2005-2010 and has taken, or is planning to take, the GCE AL exam

Who cannot apply?

1. have Turkish citizenship and have completed their entire high school education in Turkey or in TRNC
2. have TRNC citizenship (excluding those with a high school diploma from TRNC and have taken the GCE AL exam or a TRNC citizen with a high school diploma from a country other than TRNC between 2005-2010 and have taken, or are planning to take, the GCE AL exam)
3. have dual citizenship but whose first citizenship is Turkish as defined in Clause 2 of Article a (excluding those who satisfy conditions in Clause 4 of Article a)

4. have TRNC citizenship as one of their dual nationalities (excluding those with a high school diploma from TRNC and have taken the GCE AL exam or a TRNC citizen with a high school diploma from a country other than TRNC between 2005-2010 and have taken, or are planning to take, the GCE AL exam)
5. hold Turkish Nationality or were born into Turkish Nationality first but who also possess a second nationality according to Clause 2 of Article a , who have studied in the high schools belonging to Foreign Embassies or studied in international high schools in Turkey.

APPLICATION DOCUMENTS

Applicants are required to submit an online application form and upload the application documents within the application dates.

Please provide notarized translations of your documents if they are in any language other than English and Turkish.

Applications with missing documents will not be taken into consideration.

- Passport or National ID copy
- One Biometric Photo
- High School Diploma (if available)
- High School Transcripts (includes all years and grades)
- Exam results (such as SAT – if available)
- English language proficiency exam (if available)
- Turkish language proficiency exam for Turkish programs.
- Letter of Intent
- Reference letter (for Medicine program two reference letters from Math, Biology or Chemistry teachers, for others one reference letter from related subject teacher.)

*Depending on the program type, extra documents might be asked.

REGISTRATION

The Student must submit the following documents within the registration dates. Student, who fail to complete the application process within the given dates forfeit the right to education at our University.

1. Passport and national identification card copy
2. 6 biometric photographs (taken in the last 6 months, with a plain white background)

3. Original High school diploma (School Leaving Certificate/Testimonial) and certified translation in Turkish or English
4. Original final transcript
5. Equivalency Certificate (This certificate is a document stating that your high school diploma is equivalent to a Turkish high school diploma. This can be obtained from the Turkish Embassy/Consulate in your country or from the Provincial Director of National Education in Istanbul. Rules and regulations regarding the equivalence letter are subject to change as it is managed by the T.R. Ministry of Education. The students, who get equivalence rejection cannot register and registered ones will lose the right of study.
6. Tuition fee payment receipt
7. Original copy of exam results submitted during application
8. Foreign language exam result (English or Turkish - if available)
9. Valid and/or expired residence permit card copy (if available)
